

Technology for Assessing the Level of Foreign Language Proficiency of Students of Non-Linguistic Universities

To stimulate research and innovation, to create effective mechanisms for the implementation of scientific and innovative achievements, to improve the quality of training, to create the necessary conditions for the training of qualified specialists in accordance with international standards, each higher education institution to establish close cooperation with educational institutions and develop students' creative abilities, effective use of interactive methods in working with young audiences, to provide them with quality education in a foreign language, to raise the level of higher education to an exemplary level and improvements have been identified as key objectives [1].

Therefore, in order to form the ability to read the original literature on the speciality, to participate in oral communication in a foreign language in the process of production of future

personnel and finding the necessary information for scientific purposes in the higher education system of the republic classes are being held.

Every citizen of the independent Republic of Uzbekistan must be able to read the original literature in a foreign language, understand the text and use it in their profession. In addition, he should be able to communicate freely in a foreign language with his interlocutor on a given topic. After all, learning foreign languages is a requirement of today's globalized world.

At the beginning of the learning process, the teacher should focus on the student's pronunciation. Although grammar and vocabulary are important, it is useless if the speaker mispronounces them. Native speakers can also understand speech with grammatical errors if the speaker pronounces the words correctly.

Therefore, in teaching, the main focus is on pronunciation. In this case, the use of different audios of native speakers gives good results. The teacher should teach the correct pronunciation of letters and words during the lesson. There is also a strong emphasis on oral and reading skills in the early stages. If we look at the types of speech activities of foreign language teaching, the following tasks should be performed in their teaching:

- b) Improving oral reading techniques;
- c) Teach them to understand what they are reading.

Methods

Results

Given the goals and objectives of teaching English in higher education, they can be divided into 2 groups:

✚ Universities, institutes, faculties that train specialists in foreign languages English.

✚ Foreign language -non-philological educational institutions that do not train English language specialists.

The goals of teaching English in these two groups are different, and due to the training of English language specialists in the higher education institutions of the first group, English is taught in a deep and comprehensive way, both theoretically and practically. In the second group, non-philological educational institutions, there is a complex goal for English[12].

The goal is for the student to receive a general education in English and to teach him or her to use English in his or her future work. Part-time communication in the profession involves learning words related to the speciality and reading and translating texts.

The teaching of foreign languages in higher education institutions is self-contained:

- 1) practical or communicative,
- 2) general education,
- 3) upbringing,
- 4) use the acquired skills and abilities for other purposes development goals.

General, educational, and developmental goals occur in the pursuit of a communicative goal. Let's take a closer look at these 4 goals:

1. Communicative (practical) goal: Through this goal, students develop skills in English language materials. Students should be able to use lexical and grammatical pronunciation materials independently in speech. English speaking, reading and writing skills will be developed.

2. General educational goal: Through this goal to further develop students' thinking, to receive and impart information in English, to gain a deeper understanding of English, new knowledge of English and the history and literature of the people of the country where the language is studied and broadening students worldviews through the acquisition of insights and information about their culture. Students will be able to understand, develop their thinking and broaden their horizons at the expense of a foreign language or in English.

3. Educational goal: This goal is to provide intermittent, moral and aesthetic education in a foreign language - English class, as well as to develop an attitude to work. Of course, this is done by analyzing the subject of English speech, the content of English texts through English-language materials.

4. Developmental Objective: This goal defines the guidelines for learning, teaching, and learning about students personally. It develops the skills of analyzing, summarizing, drawing independent conclusions, listening, speaking, and acting on language facts.

It teaches imagination, creating a speech situation, logical connection in speech, independent thinking, understanding the meaning of words, independent work with dictionaries, manuals, and optional classes, develops independent preparation for extracurricular activities, their conduct. The above four goals are always complementary and interrelated. These four goals should be achieved through English language materials and speaking activities that are taught and repeated in each lesson.

Upon graduation, students are required to be able to receive, comprehend, and express their ideas orally and in writing, both orally and in writing. In higher education institutions that do not specialize in languages, the number of teaching hours is given in the programs of those institutions.

In non-philological educational institutions, foreign languages are taught on the basis of special curricula. Since such programs and textbooks have not yet been developed for our English special non-philological educational institutions, teachers in such Uzbek-language educational institutions use a variety of textbooks and manuals, taking into account the specifics of the direction.

The content of teaching is one of the most important issues in the methodology. Nowadays, the content of foreign language teaching in higher education institutions that do not specialize in languages is defined as the amount of knowledge, materials, exercises and skills that are determined by the goals and objectives of the education received by students. When defining the content of a subject, it is important to keep in mind two general requirements and their interrelationships:

✚ the requirement that we choose the content of the chosen teaching to achieve or not achieve the goal we set for ourselves;

✚ it is a requirement for students to master or not be able to master the content of teaching chosen in our specific context.

The content of a foreign language subject can be determined based on these two requirements. The draft Higher Education Foreign Language Program outlines the content of English language teaching. Every foreign language teacher is obliged to organize their work on the basis of this program. O.Hoshimov and I.Yakubov include the following in the content of the subject of methods of teaching foreign languages at the present time.

1. Topic: (topics) oral and reading topics.
2. Language materials (phonetics, vocabulary, grammar.)
3. Formation and development of lexical, grammatical, spelling, pronunciation skills;
4. To form, teach, develop speech skills (listening comprehension, speaking, reading, writing skills).
5. To teach the skills of working with additional literature when working on English.

Texts are selected based on the topic. The acquisition of speaking skills and activities is the essence of the practice of foreign language teaching. The content of foreign language teaching answers the questions of what and what to teach in a foreign language.

Currently, language materials in foreign languages (English, German, French) have been selected for the higher education institution. Properly selected content will help you achieve your goals. Content selection takes into account the purpose of the training and is guided by it. When the content is selected, along with the language materials, speech patterns are also selected. They are the basis for teaching speech. The choice of content takes into account the methodological organization of teaching. The content of the training depends on the conditions of the training. The purpose of foreign language teaching also affects the scope of teaching content[5].

Nowadays, it involves a radical change in foreign language teaching. It has the following 3 requirements.

1. Improving the scientific level and practicality of foreign language teaching;
2. Strengthening the educational aspect of the subject of a foreign language;
3. Independent study of a foreign language subject.

The first requirement can be met in two ways.

Line 1. Change the content of the training.

Line 2. Reconstruction of foreign language teaching methods.

The old method of reconstruction, which is not relevant today, is to improve the education system by removing the roads. Improving the scientific level of foreign language methodology is the popularization of best practices, the reconstruction of the methodology on the basis of innovations in linguistics, psychology, pedagogy, psycholinguistics. For a foreign

language to be practical, the student must focus on the ability to work independently and competently on the foreign language.

The future of any society is determined by the level of development of its education system, which is an integral part of it and a vital necessity. Today, reforming and improving the system of continuing education in our country, which is on the path of independent development, raising it to a new level of quality, the introduction of advanced pedagogical and information technologies and improving the efficiency of education has become a state policy[10].

In the process of development of pedagogical technologies and their integration into the educational process, as well as the rapid exchange and improvement of information technology, everyone has the opportunity to strengthen their professional training and skills. The introduction of advanced pedagogical technologies in the educational process is one of the milestones of the National Training Program. 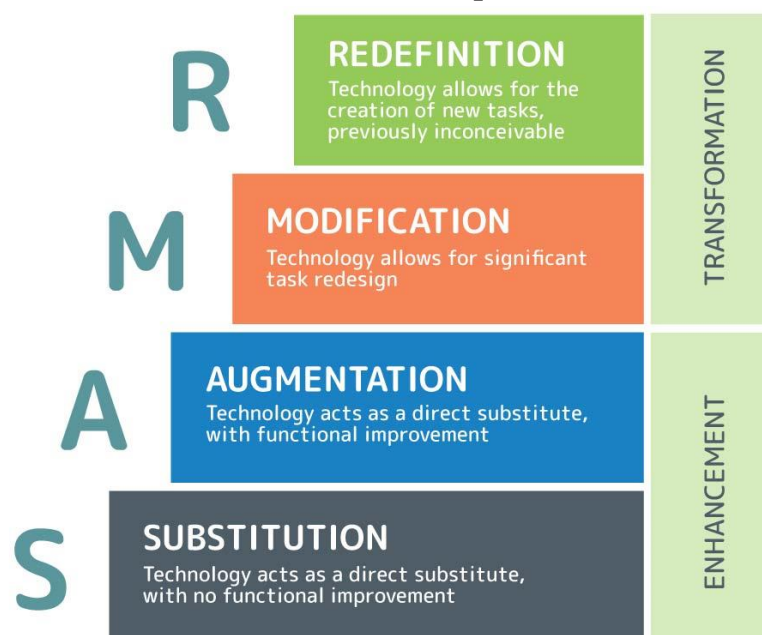
